- -Reviewed the income statement for the general fund for fiscal year 2018
- -Eliminated the position of constituent societies liaison, as these responsibilities are being handled by others.
- -Authorized CEO Balasa to contact CAAHEP and ABHES accredited programs in other health care disciplines regarding their willingness to give advanced standing to CMAs (AAMA) who have graduated from a CAAHEP or ABHES accredited medical assisting program.
- -Allocated a reserve of \$100,000 to the CEB to use in developing future Assessment Based Certificate programs for CEU credit.
- -Reviewed the updated Strategic Issues Plan and approved it.
- -Reviewed and accepted a report from CEO Balasa on his schedule of upcoming live via phone CEU presentations on the Professional Less Regulation Movement.
- -State and chapter leaders were in attendance from Colorado, Michigan, and Wisconsin.
- -Reminder that AAMA Volunteer forms are on AAMA website. Anyone desiring to be on a committee should fill out a form. Anyone desiring to run for trustee must run from the floor as the deadline was April 1.

UNFINISHED BUSINESS

*Ad Hoc committee United WE Stand will be disbanded. It has accomplished what it set out to do and will continue to do so in the future. Several chapters used the letters that were proposed by this committee and will continue to do so in the future. Loxie Kistler, CMA (AAMA) reports that the letters were sent out to organizations and large employers to let them know about opening our society to all credentialed medical assistants and our hopes to raise the bar for education for all medical assistants. We got response to some letters and some we did not. Some face to face contact happened as well with some growth in chapters. Mary Lou found that for non CMA (AAMA) members, the numbers have been up and down over the years, so there is uncertainty right now as to how the letters and communication done by this committee will pan out. This is a work in progress and will take time over the next several years to see if membership does increase. The free CEUS online have been well received by members with a lot of positive feedback. Since last April over 1,000 free CEUS have been given to members. Our membership is up from 800 in August of 2017 to now where we have 1,100 members. We want to continue to grow in all areas of social media to get the word out in order to increase our membership.
