Correspondence:

- 1. President Deniece received correspondence from the AAMA that FSMA will be allowed FIVE (5) delegates for the 2023 AAMA National Conference. The number of delegates is based on year-end membership total of active members. The number of FSMA active members as 12/31/2022 was 969.
- 2. Deadline to volunteer for AAMA National Committees is August 1, 2023.
- 3. Deadline for AAMA Excel Awards is August 1, 2023. There will be an entry submitted for FSMA in the Website category. Brevard Chapter is considering submitting an entry again for Employer of the Year for HealthFirst. There is a

- new award this year called The Rising Star award given to AAMA members within the first 5-7 years of their certification who have shown "dedication as a state society or local chapter champion".
- 4. Deadline to run for AAMA Trustee is May 1, 2023.
- 5. Deadline to submit Delegate/Alternate forms is July 25, 2023

Unfinished Business:

- 1. The Ad-hoc committee led by Committee Chair Betty Springer, CMA-C (AAMA) focusing on the program on student member engagement after graduation has been named "STAR Force" (Students Taking Active Roles). The goal of this committee is to guide student members to participate in their local chapters and on the state level. The committee chair stated she is working with chapter presidents and has received great feedback and ideas. A draft version of a lapel pin designed by Jennifer Shepard, CMA (AAMA) was shown. The lapel pin will be given to student members to wear at in-person meetings so they will be identifiable as STAR Force members. Estimates are being gathered for the manufacturing of the lapel pin. The committee will continue to meet to further develop the program. Committee Chair Betty announced she is stepping down, and Jeanette Tyler will assume the Chair position.
- 2. Ways and Means Table at AAMA: as host society, FSMA is allowed two ways and means tables. FSMA is looking for two vendors to sell items at the conference with a small portion of the proceeds going to FSMA. President Deniece asked to be notified with interested persons. Ideas included Scentsy representatives or companies that make badge reels or other profession-related items.
- 3. The topic of having an FSMA annual meeting as part of a weekend cruise was discussed. It was suggested that the membership be polled about interest before pursuing further.
- 4. Marsha Benedict, CMA-A (AAMA)moved that FSMA members should wear the green FSMA badge holders to be identifiable as the host state at the AAMA Conference. Mary Lou Allison, CMA-C (AAMA) seconded the motion. No discussion. Motion carried.

New Business:

1. There was discussion regarding nominating Patty Rock, LPN, Program Director at Eastern Florida State College for the Golden Apple Award at the National Conference. The guidelines for this award state that the educator must be from a CAAHEP institution, which EFSC is no longer accredited by them. Patty has been a promoter of the AAMA since she began as an instructor in the medical assisting program at EFSC. She has also been a member for many years and has attended several national

conferences. There was discussion regarding FSMA creating their own Golden Apple Award for Outstanding Florida Educator in a Medical Assisting Program. Marsha Benedict, CMA-A (AAMA) moved that FSMA create this award. Mary Lou Allison, CMA-C (AAMA) seconded. No further discussion. Motion carried.
