Meeting Coordinator--Marsha Benedict, CMA-A (AAMA) Addendum to report on file: Registration fees for the annual meeting will be: \$30 for FSMA members, \$15 for student members, and \$45 for non-members. Registration includes Friday night activities and Saturday education sessions, with lunch included.

Membership/Certification--Jeanette Tyler, CMA (AAMA) Addendum to report on file: The current membership number for FSMA is 579. Report on file stated a different number that was before the non-renewals were removed from the list by AAMA National office. In a survey that was sent out by the national Membership Committee, one of the main reasons members did not renew is because they see "no benefit" in being a member. Two things were suggested to the FSMA Membership Committee Chair: 1) create an eblast to non-renewals emphasizing the benefits of membership; 2) Analyze non-renewals to find patterns.

Nominating Committee--Jeanette Tyler, CMA (AAMA) Addendum to report on file: The Chair received a great response to the Consent to Serve eblast that was sent. One person has committed to being the Education Chair for FSMA for 2024-25. The Nominating Chair is looking forward to receiving more Consent to Serve forms in her email soon.

## <u>Unfinished Business:</u>

1. Treasurer Mary Lou Allison, CMA-C (AAMA), clarified that chapters could set up registration forms for individual CEU meetings to include payments, but the funds would go to PayPal,

which charges a fee for this. Further discussion regarding standardizing the fees for using the FSMA ZOOM to charge \$10 for non-members. All AAMA members would be free. This is to help promote membership as a benefit. Mary Lou Allison, CMA-C (AAMA) moved to make all CEUs via FSMA ZOOM free to all AAMA members and \$10 for non-members. Christina Sears, CMA (AAMA) seconded. Motion carried.

#### **New Business:**

- 2026 FSMA Annual Meeting: Marsha Benedict, CMA-A (AAMA), moved that the 2026 annual meeting be held at the Holiday Inn Lake Buena Vista (same as 2023 and 2024). Christina Sears, CMA (AAMA) seconded. Motion carried.
- 2. Mary Lou Allison, CMA-C (AAMA), would like to create a database of speakers (a type of "speakers bureau") that would offer speakers \$50 per hour to present CEU topics. The funds would come from the Southeast Chapter treasury, since it would be providing a service to their members. Mary Lou will meet with President Deniece and Vice President Jeanette to discuss this topic further and to set parameters for the database.
- 3. President Deniece, on behalf of Bylaw Committee Chair Judy Seymour, CMA (AAMA) stated that bylaw proposals should be sent to her as soon as possible.
- 4. Speaker of the General Assembly Christina Sears, CMA (AAMA), is requesting guidance and assistance with the General Assembly in April. Maria Wiegelmann, CMA (AAMA), stated she would help and lend guidance.
- 5. Christina Sears, CMA (AAMA), presented some marketing item ideas—tumblers and stickers. Christina has found a company that could create round vinyl stickers with the green FSMA logo for a good price. These stickers would be given away to attendees at the Annual meeting, as well as given to chapter presidents to hand out at their in-person events as a marketing tool. After discussion, Jeanette Tyler, CMA (AAMA) moved that FSMA purchase 1,000 round vinyl stickers for the price of \$123.50 plus shipping. Mary Lou Allison, CMA-C (AAMA), seconded. Motion carried.

Christina also showed a sample of tumblers that a different company created. These would be insulated tumblers with the FSMA logo etched on them. The minimum purchase price is \$250. Twenty (tumblers) would cost approximately \$315, bringing the price to 15.75 each. Mary Morris, CMA (AAMA), suggested that Christina bring the samples to the annual meeting to gauge interest before purchasing 20 of them. Christina will bring them to the meeting.
